--: ORDER UNDER SECTION 12AA OF THE INCOME TAX ACT, 1961 --:

1. The above Trust/Society/Institution was constituted by a Trust Deed/Memorandum of Association on 08-03-1988.
2. The above Trust/Society/Institution has filed an application seeking registration u/s.12A of the Income Tax Act, 1961 on 01-12-2003 in the prescribed format after a delay of more than 15 years. The society has not sought for condonation of the delay.
3. Hence, the delay is not condoned.
4. However, on going through the objects of the Trust/Society/Institution and activities as enumerated in the Trust Deed/Memorandum of Association, I am satisfied about the genuineness of the Trust/Society/Institution as on date. Hence, registration u/s.12A is granted w.e.f. 01-04-2003 i.e. the first day of the financial year in which the application has been made.
5. The above registration u/s.12A does not mean that the income of the Trust/Society/Institution is automatically exempt under sections 11 & 12 of the Income Tax Act, 1961. This will be examined independently by the Assessing officer on facts and according to the provisions of the Act.
6. The application has been entered at Sl.No.17 of Page No.4 in the register u/s.12A maintained in the Office. This number may please be quoted in all future references.
